

# **ALSTON MOOR PARISH COUNCIL ANNUAL REPORT 2015/2016**

## **CHAIR'S REPORT**

I am pleased to present the annual report from Alston Moor Parish Council. We welcomed some new faces on the council following the May 2015 elections, and said goodbye to several long-standing members. Sadly, John Glendinning's injury has meant that he has only just been able to start attending council meetings.

Our monthly meetings are but one element in the work of the parish council. We have established working groups on specific issues, and a great deal of other 'behind-the-scenes' work goes on at all times. We aim to ensure that the best interests of the whole of Alston Moor are safeguarded and promoted, whether that be in dialogue with Eden District Council or Cumbria County Council, working with other local groups or individuals, responding to local concerns, or lobbying various bodies that have an impact on our community.

Looking back, I realise it has been another challenging year, but with some real highlights. Who could forget the excitement of watching the Tour of Britain live or in the Town Hall on the big screen? Then the decision by Go North East buses to run a regular service to Haltwhistle has re-connected us to the major public transport systems, which combined with the Community minibus, available for hire and at times for certain routes connecting to other public transport, makes life a little easier for those without, or not wishing to always use, a car.

With the backing of the parish council, I worked hard with local residents Malcolm Forster and Adrian Rush to try to save Barclay's Bank. Although this proved impossible, we did succeed in keeping the ATM, at least for another year. Please use it, so we can demonstrate the ongoing need. There have, unfortunately, been problems with setting up the Alston Ambulance, but we have been working closely with the North West Ambulance Service and I am confident that we will have a good ambulance service before long. The recent Success Regime report on the future of Cumbria's hospitals, including a threat to the in-patient beds at Alston Cottage Hospital, means that there can be no let-up in the fight to retain services on Alston Moor. We managed to get a superb turn-out for the initial consultation on the proposals, and many others have completed the questionnaire online or via the posting to every home on Alston Moor. Now we need to follow-up with attendance at a meeting which will be held at Samuel King's School on Tuesday 10 May at Alston Town Hall. Please come along, hear what the Success Regime have to say, and make sure our views are clearly heard.

#### COUNCIL RESPONSIBILITIES

**Alston and Nenthall War Memorials** – the parish council actively supports the volunteers who are fundraising to renovate the war memorials to commemorate 100 years since the start of WW1.

**Alston Town Hall** – the parish council is the sole trustee of Alston Town Hall.

**Fairhill Estates Charity** – parish councillors are also trustees to this charity, whose income comes mainly from land rents. Anyone from the parish experiencing financial difficulty is welcome to apply.

**Fairhill Recreation Grounds Car Park** – the parish council has taken on the lease for the car park, contributing annually towards maintenance costs carried out by the trustees.

**Firs and Henderson's Woods** – the council owns Firs Wood and leases Henderson's Wood.

**Tyne Willows Car Park** – is available for users of the field, who are asked to respect the space; please don't litter or abandon vehicles, and clear up after your dog.

**Tyne Willows Pavilion** – is owned by the parish council and leased on a peppercorn rent to Alston Fitness Club

**Tyne Willows Playing Fields** – are leased as a school playing field, but may be hired for community events.
