WAMM report

NMCS are of the opinion that the work schedule the CB are carrying out on the old pipeline from the Mines car park to Hansom Mea is behind schedule, this makes it less likely their planning application will go ahead in the autumn.

We are going to conduct our own botany survey and we have a well-respected Botanist who has volunteered to do this.

We need some funding to be able to pay expenses, so an application for £300 has been submitted.

We are putting together a petition of Nenthead residents to present to NMCS to show the depth of feeling against the WAMM project, a public meeting will be called within the next couple of weeks.
